3. Before participating in any SCUBA diving activity, I will have completed all required training for that activity and be properly certified. I will follow all safety rules, regulations, and or procedures taught to me during such certification training.

I do hereby assume any and all risks inherent in my participation in any of the activities of the DIVE CLUB, and I DO HEREBY forever for myself, my heirs, executors, personal representatives, administrators, and assigns DISCHARGE and RELEASE the DIVE CLUB, its sponsors, officers, directors, members, agents, and/or servants from any and all liabilities, claims, actions, causes of actions, demands, damages, costs, loss of service, expenses, compensation, personal injuries, death, and property damage arising or resulting from my participation in or attendance at, any DIVE CLUB activities, including, but not limited to, all such liabilities, claims, actions, causes of actions, demands, damages, costs, loss of service, expenses, compensation, personal injuries, death, and property damage which may arise or result from the negligence or alleged negligence of the DIVE CLUB, its sponsors, officers, members, agents, or servants.

Further, I agree to indemnify and save and hold harmless the DIVE CLUB, its sponsors, officers, directors, members, agents, and/or servants from any and all liabilities, claims, actions, causes of actions, demands, damages, costs, loss of service, expenses, compensation, personal injuries, death, and property damage arising or resulting from my participation in or attendance at any DIVE CLUB activities, including, but not limited to, all such liabilities, claims, actions, causes of actions, demands, damages, costs, loss of service, expenses, compensation, personal injuries, death, and property damage which may arise or result from the negligence or alleged negligence of the DIVE CLUB, its sponsors, officers, members, agents, or servants.
